1. On 6 February 2018, Radovan Karadzic moved for reclassification of the *Application Pursuant to Rule 86(F)(i) Rules of Procedure and Evidence MICT* (26 April 2017) from *ex parte* to confidential.<sup>1</sup> Since the name of the Applicant had been redacted, he indicated on the cover page of the motion that the motion should be served on “Defence Counsel for [REDACTED]”.

2. On 15 February 2018, the Registry advised that “since there is no name on the cover page for the Defence Counsel for (redacted) Registry is not able to distribute/serve the motion in question, pending any further judicial determination by the Chamber.”


3. In his *Motion for Reclassification*, President Karadzic had requested that the Applicant, “after being served with this motion, voluntarily agree to the reclassification of the application.” This cannot be accomplished if the Applicant is never served with the motion.

4. In addition, the Applicant is a party to the proceedings in case no. MICT-13-55-R86F.6. The fact that its identity is kept from President Karadzic should not deprive it of the opportunity to receive filings and participate in the proceedings. If the Applicant is the Court of Bosnia and Herzegovina, it should likewise be served with the motion so that it can consult with the Defence Counsel on whose behalf the application was filed and provide its position to the Appeals Chamber.

5. For all of the above reasons, the Appeals Chamber is respectfully requested to serve the *Motion for Reclassification*, as well as this *Motion for Service of Reclassification Motion* on the Applicant and/or its counsel.
