1. Dr Radovan Karadzic hereby moves for an order reclassifying the Registrar's submissions on the malignancies at the United Nations Detention Unit from confidential to public.


2. Following the President's request that the Registrar look into President Karadzic's complaints about the extraordinary number of illnesses and deaths among persons held at the United Nations Detention Unit, the Registrar has filed confidential submissions on 23 June, 26 August, 6 September, and 11 November updating the President and the parties on the status of its investigation.<sup>1</sup>

3. There is no good reason for maintaining those filings under seal. The issue is of public interest,<sup>2</sup> and the confidential nature of the filings precluded President Karadzic and his counsel from alluding to information about the Registry's investigation at the status conference until revealed in open court by the President.

4. Informal consultations with the Registry have not produced an agreement that the pleadings be reclassified, and has necessitated the filing of this motion.
